NOTICE IS GIVEN that the Forest of Dean District Council have on 23<sup>rd</sup> April 2007 confirmed a Direction made under Article 4(2) of the Town & Country Planning (General Permitted Development) Order 1995 which came into effect on 15<sup>th</sup> January 2007 and was to expire at the end of six months from that date unless confirmed. The effect of the Direction is that the permissions granted by article 3 of the General Permitted Development Order referring to particular classes of development the Parts listed in the Schedule below and referred to in Schedule 2 to the said Order shall not apply to such developments and such developments shall not be carried out within that area unless planning permission is granted by the Council.

Notice was given of the making of the Direction on 15<sup>th</sup> January 2007 and that was followed by a period of public consultation expiring on 15<sup>th</sup> February 2007. No representations were received and it was decided that the Direction be confirmed.

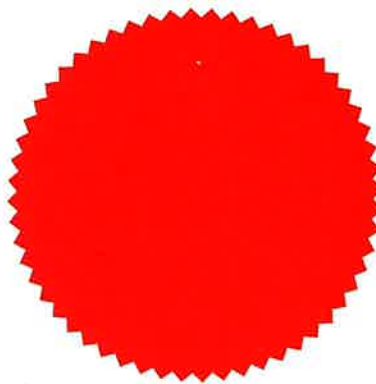
