PUBLIC PATH ORDER 2023

THIS ORDER is made by FOREST OF DEAN District Council under section 257 of the Town and Country Planning Act 1990 because it is satisfied that it is necessary to divert the Footpath to which this Order relates to enable development to be carried out in accordance with planning permission granted under Part III of the Town and Country Planning Act 1990 namely the erection of an agricultural general purpose building.

BY THIS ORDER:

- 1 The footpath over the land shown by a bold black line on the attached map and described in Part 1 of the Schedule to this Order ("the Schedule") shall be diverted as provided below.
- 2 There shall be created to the reasonable satisfaction of Gloucestershire County Council an alternative highway for use as a replacement for the said footpath as provided in Part 2 of the Schedule and shown by bold black dashes on the attached map.
- 3 The diversion of the footpath shall have effect on the date on which Gloucestershire County Council certify that the terms of Article 2 have been complied with.
- 4 Where immediately before the date on which the footpath is diverted there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.

SCHEDULE

PART 1

The entire width of that length of HEWELSFIELD & BROOKWEIR Footpath No FHE42 running from OSGR 5684/0223 (Point A) in a north easterly direction for approximately 483m to OSGR 5730/0240 (Point B) as shown between Points A – B on the plan attached to this Order.

PART 2

A new Footpath running from OSGR 5730/0240 (Point B) in a south- south westerly direction remaining to the east of the field boundary and passing through the southerly field boundary at OSGR 5710/0207 (Point D) and continuing in a generally south-south-westerly direction and exiting the fields on to Barnage Lane at 5715/0212 (Point C) a distance of approximately 386m shown between points B- D – C.

The width of the new footpath is 2.0m between points B – D – C.

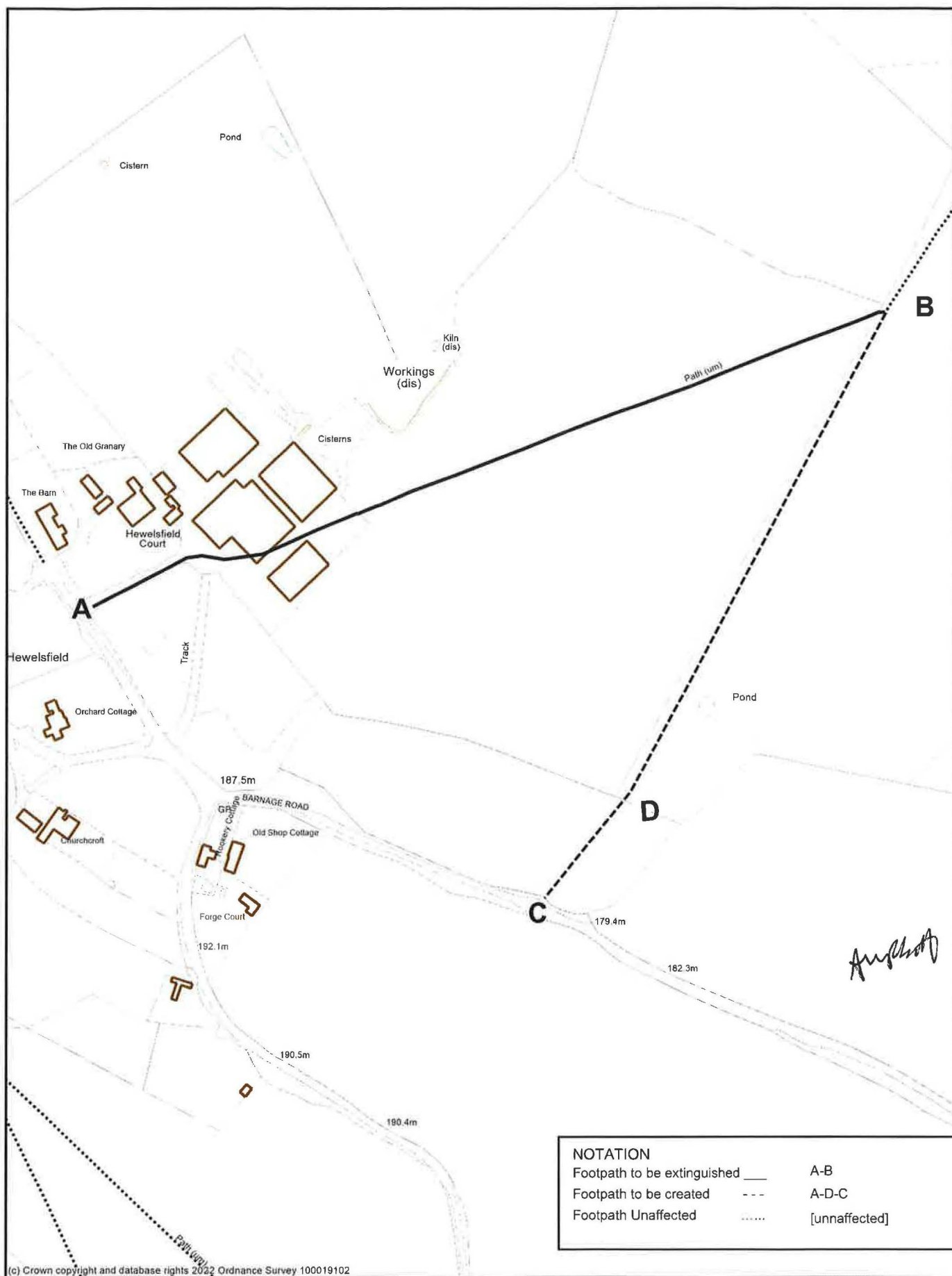
