# LONGHOPE Footpath No. DLH/17 (Part) PUBLIC PATH DIVERSION ORDER 2020

THIS ORDER is made by Forest of Dean District Council under section 257 of the Town and Country Planning Act 1990 because it is satisfied that it is necessary to divert the Footpath to which this Order relates to enable development to be carried out in accordance with planning permission granted under Part III of the Town and Country Planning Act 1990 namely the erection of a 1.8 metre high close boarded fence with a 1.2m laurel hedge in front and diversion of public footpath to go around the rear and side of car park. (Revised Scheme).

## BY THIS ORDER:

- 1 The footpath over the land shown by a bold black line on the attached map and described in Part 1 of the Schedule to this Order ("the Schedule") shall be stopped up as provided below.
- There shall be created to the reasonable satisfaction of Gloucestershire County Council an alternative highway for use as a replacement for the said footpath as provided in Part 2 of the Schedule and shown by bold black dashes on the attached map.
- 3 The diversion of the footpath shall have effect on the date on which Gloucestershire County Council certify that the terms of Article 2 have been complied with.
- Where immediately before the date on which the footpath is diverted there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.

## SCHEDULE

#### PART 1

The entire width of that length of LONGHOPE Footpath No. DLH/17 running from OSGR SO68227 20368 (Point A) in a general north easterly direction approximately 19m to OSGR SO68241 20384 (Point B) as shown between Points A – B on the plan attached to this Order.

#### PART 2


A new Footpath with an unenclosed width of 2m running for approximately 14m from OSGR S068246 20347 (Point C) in a general east-north-easterly direction to OSGR SO68238 20345 (Point D) before continuing in a generally north-north-westerly direction to join the existing footpath for approximately 36m to OSGR SO68241 20384 (Point B) as shown between points C - D - B on the plan attached to this Order.

A kissing gate is proposed at OSGR SO68249 20349 shown at Point E on the plan attached to this Order.
