Forest of Dean District Council ("the Council") in exercise of its powers under Sections 32, 35 and Schedule 9 of the Road Traffic Regulation Act 1984 ("the 1984 Act") and under the Road Traffic Act 1991 as amended (whether generally or in relation to the area of the Council) ("the 1991 Act") and of all other enabling powers, with the consent of the Gloucestershire County Council in accordance with Section 39(3) of the 1984 Act and after consulting with the Chief Officer of Police in accordance with paragraph 20 of Schedule 9 to the 1984 Act, hereby make the following Order:-

**PART I  
GENERAL**

Commencement and Citation

1. This Order shall come into operation on the **1<sup>st</sup> day of December 2025** and may be cited as the Forest of Dean District Council (OFF-STREET PARKING PLACES) VARIATION ORDER NO.1 of 2025

Interpretation

2. In this Variation Order, except where the context otherwise requires, the following expressions have the meanings respectively assigned to them:

**"the Principal Order"** means the FOREST OF DEAN DISTRICT COUNCIL (OFF-STREET PARKING PLACES) ORDER 2012 (as amended);

3. Except where the context requires otherwise, any reference in this Order to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order
4. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment
5. The Interpretation Act 1978 shall apply for the interpretation of this Order

**PART II**  
**Variation of the Principal Order**

**Additional Parking Places**

6. In this Part II "Additional Parking Places" means:

BLAKENEY, Butlers Mead;  
LITTLEDEAN, Grange Lane;  
COLEFORD, Pyarts Court; and  
CINDERFORD, Rowandean

7. Schedule 1 of the Principal Order "Schedule 1 – List of Parking places and restrictions that apply" shall be amended to insert the Additional Parking Places and restrictions that apply thereto as attached at Part I of the First Schedule to this Variation Order.
8. Schedule 2 of the Principal Order "Schedule 2 – Plan" shall be amended to insert the Plans in respect of the Additional Parking Places as attached at Part II of the First Schedule to this Variation Order

**Addition of Electric Vehicle Charging in Parking Places**

9. The first Schedule of the Principal Order "Schedule 1 – List of Parking places and restrictions that apply" shall be amended to include the "Supplementary Restrictions" ("Class of Vehicle – Electric Vehicles") as set out at Part III of the First Schedule to this Variation Order.

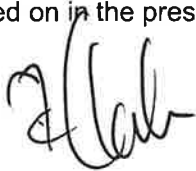
**Variations to the Car Park Usage Policy**

Monthly, 3 monthly, 6 monthly and annual permits may be purchased on the Forest of Dean District Council website*";
- F. Deletion of Schedule 4 paragraph 28.4;
- G. Substitution of Schedule 4 paragraph 28.5. The paragraph is to be deleted and replaced with "*The permit is valid in any Council owned car park*";
- H. Deletion of Schedule 4 paragraph 28.6;
- I. Deletion of Schedule 4 paragraph 28.7;
- J. Deletion of Schedule 4 paragraph 29.
