# DRYBROOK Footpath DDB9 (Part) & DRYBROOK Footpath DDB10 (Whole) PUBLIC PATH DIVERSION ORDER 2021

THIS ORDER is made by Forest of Dean District Council under section 119 of the Highways Act 1980 because it appears to the Authority that it is expedient that the path should be diverted in the interest of the owner of the land crossed by that part of the footpath described in Part 1 of the Schedule to this Order.

## BY THIS ORDER:

- 1 The footpaths over the land shown by a bold black line on the attached map and described in Part 1 of the Schedule to this Order ("the Schedule") shall be stopped up as provided below.
- 2 The alternative highways as provided in Part 2 of the Schedule and shown by bold black dashes on the attached map shall be used as a replacement for the said footpath.
- The diversion of the footpath shall have effect on the date on which this Order is confirmed.
- Where immediately before the date on which the footpath is diverted there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.

## **SCHEDULE**

## PART 1

That length of public footpath numbered DRYBROOK Footpath DDB9 that commences at a point marked B south of the boundary to Drybrook rugby pitch and north of the barn at Manning's Farm at SO 6516/1770 in a south easterly direction to a point marked C at SO 6525/1762 to the north north-east of the property called "Lawnswood" being approx. 109m in total and of undefined width as shown between Points B – C on the plan attached to this Order;

#### And

That length of public footpath numbered DRYBROOK Footpath DDB10 that commences at a point marked A south of the boundary to Drybrook rugby pitch and north of the barn at Manning's Farm at SO 6515/1767 in a general southerly direction for approx. 132m to a point marked D to the south of "Manning's Farm" yard at SO 6519/1755 and of undefined width as shown between Points A – D on the plan attached to this Order;

#### PART 2

A length of footpath with an unenclosed width of 2m that commences at the point marked A south of the boundary to Drybrook rugby pitch and north of the barn at Manning's Farm at SO 6515/1767 running in a north easterly direction along the field edge for approx. 27m through point B at SO 6516/1770 to a point marked E (SO 6518/1769) before arching around an earth bund in a general south east direction for approx. 51m to a point marked F (SO 6521/1767) and continuing in a south easterly direction for approx. 65m to a point marked C to the north north-east of the property called "Lawnswood" (SO 6525/1762) and re-joining DRYBROOK Footpath DDB9 as shown between points A - B - E - F - C on the plan attached to this Order.

A new stile is proposed at SO 6517/1769 shown at Point E on the plan attached to this Order.

#### And

A length of footpath with an unenclosed width of 2m that commences at the point marked F (SO 6521/1767) to the south-east of the earth bund running in a southerly for approx. 69m to a point marked G (SO 6523/1760) and turning approximately south south-west and running for approx. 73m to a point marked H (SO 6521/1753) as shown between points F-G-H on the plan attached to this Order.

New stiles are proposed at SO 6523/1760 shown at Point G and at SO 6521/1753 shown at Point H on the plan attached to this Order.
