What is a Local Plan?

The Local Plan will explain how the district is expected to change over 20 years, showing sites that are chosen for new housing, to provide jobs, and are needed for other uses. It will also protect land and the quality of the environment. It must help reduce carbon emissions.

It adds a local dimension to planning which would otherwise be guided only by national policies which may not be as sensitive to the needs of the area as a Local Plan can be.

Our new plan will be known as Local Plan 2021 - 2041. A full timeline of the Local Plan Process can be found on the back page of this document

What are Issues and Options?

This document outlines key issues and spatial options for the area. As we are creating a new Local Plan a full review is required of all existing policies.

Issues are subject areas which the plan needs to consider and include it should then include policies and proposals which address them. The options consider the pattern and nature of the changes to land that may address these issues. An issue may be to provide additional employment, an option may be to identify land in one location or another, for example.

Can I comment on the Issues and options Document?

The consultation on the Issues and Options for the Local Plan commences Tuesday 17th September 2019, and closes at 4.30pm on Thursday 31st October 2019



What comments can I make?

Examples of matters to think about:

- What do you think of the issues and options we have identified?
- Where do you think new housing should be located?
- How can we protect our environment and heritage?
- Is there enough employment land?
- How can we achieve carbon neutrality?
- Are we doing enough to protect our wildlife?

Local Plan Process

Preparation

This is the longest stage of the process taking 2+years.

1. Issues and Options - The development of issues and options is the first in a number of stages in the production of the revised Local Plan and is the first opportunity for residents, businesses and other interested parties to be involved in planning for our future.
2. Draft Plan - Your views, along with the evidence that supports the Local Plan and the outcome of the Sustainability Appraisal will be used to help develop our new Local Plan to the next stage when we will produce a draft plan.

Publication

This is a stage where more formal comments are sought. Anyone can comment and these comments form part of the evidence used in the public inquiry (Examination) of the plan which follows.

Submission

The plan and comments from the publication are submitted to the Secretary of State for examination.

Public Examination

Examination of the Plan by an Inspector appointed by the Secretary of State This will include hearings and these will consider comments made in relation to the plan.

The Inspectors Report

The Inspector may direct that a plan be withdrawn, but will generally guide the examination to a point where he or she can recommend changes to the plan needed to make it sound (able to become part of the development plan)

Adoption

The plan will be adopted and given full weight in planning decisions.
